



**Internews first “Every Human Has Rights” Media Awards
30 award winners to travel to Paris
Public invited to vote online for best story**

(November 4th, 2008)

Internews is pleased to announce the **30 winners** of the Every Human Has Rights Media Awards (see full list of winners below). The winners will travel to Paris in December for the awards ceremony.

The call for participation was heard by numerous journalists and citizen journalists all around the world: **482 applications** were received, with stories covering 108 countries.

Following national then regional selection processes, the 30 winners were chosen by an **international jury** of journalists and human rights experts: Marcia Poole (journalist and Senior Director, Communications & Information of Amnesty International), Aidan White (journalist and General Secretary of the International Federation of Journalists), Katy Cronin (journalist and Communications Director of The Elders), Lydia Cacho (journalist and author), Jimmie Briggs (journalist, author, Executive Director of *Men Call An End* and Chairman of the jury), Bonnie Abaunza (Vice President Campaign Development & Operations for Participant Media) and Mariane Pearl (journalist).

“It is my honour to have participated in the award deliberations of global reportage exemplifying the highest levels of integrity and professionalism. The injustices and transcendent challenges they expose are the strongest argument to the relevance and importance of the Universal Declaration” says **Jimmie Briggs**, Chairman of the jury.

The 30 winners are awarded an all expenses paid trip to Paris from December 5th to December 11th, 2008.

On Saturday December 6th, they will attend the **Every Human Has Rights campaign celebration** including the **Awards Ceremony**. They will have the opportunity to meet a number of personalities from the human rights and media communities, including M. **François Zimeray**, French Ambassador for Human Rights; M. **Stéphane Hessel**, former Ambassador to the UN and a co-drafter of the UDHR in 1948; Ms. **Mary Robinson**, Former President of Ireland, Former UN High Commissioner for Human Rights and member of The Elders; and Archbishop **Desmond Tutu**, Nobel Peace Prize Laureate and Chair of The Elders.

Award winners will be assisted by Internews in Paris to attend and report on other human rights related events in the lead up to the 60th Anniversary of the Universal Declaration on December 10, 2008.
